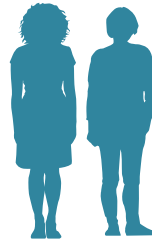




Early Childhood Workforce Index 2016 NEW JERSEY

IN NEW JERSEY, there are 638,926 children age birth through five years; 66 percent of these children live in households where all available parents are currently working, and 19 percent of all New Jersey children are part of low-income families. It is widely agreed that the current early care and education system across states is woefully underfunded. The [cost of services](#) is out of reach for many working families, including those who earn middle-class wages. At the same time, large swaths of early childhood teachers — even those with college degrees — earn unlivable wages.

More than 31,130 members of the early childhood teaching workforce provide services to children in New Jersey.

Selected Occupations Ranked by Earnings

- In 2015, the median wage for child care workers was \$10.61, **a 1% decrease since 2010.**
- For preschool teachers, the median wage was \$16.90, **a 2% increase since 2010.**

Use of Public Income Supports (EITC, Medicaid, Food Stamps, TANF)

- Child care worker families' participation in one or more public income support programs: **39%**
- Cost of child care worker families' participation in public income support programs: **\$39.2 million**
