**IN DISTRICT OF COLUMBIA**, there are 51,957 children age birth through five years, and 15 percent of all District of Columbia children are part of low-income families. It is widely agreed that the current early care and education system across states is woefully underfunded. The [cost of services](#) is out of reach for many working families, including those who earn middle-class wages.

At the same time, large swaths of early childhood teachers — even those with college degrees — earn unlivable wages. More than 3,350 members of the early childhood teaching workforce provide services to children in District of Columbia.

## Earnings by Occupation

- In 2017 the median wage for child care workers was \$14.33, **a 26% increase since 2015.**
- For preschool teachers the median wage was \$18.02, **a 9% decrease since 2015.**
- For preschool or child care center directors, the median wage was not available.

\*Total includes the following occupations as defined by the U.S. Bureau of Labor Statistics Occupational Employment Statistics (OES): "child care workers," "preschool teachers, excluding special education," "preschool teachers, special education," "education administrators: preschool/child care center programs". These data do not include the self-employed, although home-based child care assistants, who are employees, are likely included in the "child care worker" category. Due to the limited data available across states in the OES, state-based surveys or registries may provide more comprehensive estimates of the ECE workforce.
